- g) Kasasa Tunes® Welcome Reimbursement (from Amazon® & iTunes Store®) – \$30.00 expires after 30 days
- h) Kasasa Tunes® Monthly Reimbursement (from Amazon® & iTunes Store®) – \$8.00 expires after 30 days  
-Welcome & Monthly Reimbursements are from signature based purchases\* only made at Amazon.com® & iTunes Store®

\*You must opt out of PIN-less Debit on Amazon.com® by editing your payment method for your debit card and uncheck the box that says “processed as debit card”
